WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry out domestic and foreign contracts subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, the TESDA-Region V, through its Regional Bids and Awards Committee (RBAC) engaged to conduct the bidding for the Construction of Manpower Training Center for Viga and Pandan, Catanduanes by publishing an Invitation to Bid in one (1) newspaper of local general circulation for two (2) consecutive weeks and posted the same in TESDA-Region V website and in a conspicuous places in the premises of the TESDA Regional, Provincial Offices and Schools/Training Institutions continuously for fourteen (14) calendar days;

WHEREAS, the bidding was conducted in accordance with Republic Act 9184 otherwise known as the "Government Procurement Reform Act";




