APPROVING THE AWARD OF CONTRACT TO LGC TRUCKING AND CONSTRUCTION IN THE AMOUNT OF Php9,155,620.22 FOR THE CONSTRUCTION OF THE BISLIG MANPOWER SKILLS TRAINING CENTER (BMSTC) AT BISLIG CITY, SURIGAO DEL SUR

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry out domestic and foreign contracts subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, TESDA Caraga has a Capital Outlay Budget as reflected in the 2008 Government Appropriation Act (2008 GAA) for the construction of the Bislig Manpower Skills Training Center (BMSTC) thru the initiative of the Hon. Cong. Florencio C. Garay of the Second District of Surigao del Sur to address the need for skills of his constituents in the district and to respond to the market demand for highly skilled workers in the local and national scope and abroad;

WHEREAS, the TESDA Region CARAGA, through its Regional Bids and Awards Committee (RBAC), engaged to conduct the bidding for the Construction of Manpower Training Center at Bislig City, Surigao del Sur by publishing an Invitation to Bid at the PhilGEPS on July 24, 2009 and in the Mindanao News Courier on July 14-21 and 22-27, 2009;

WHEREAS, the scope of works for construction of Bislig Manpower Skills Training Center (BMSTC) have been identified by the Executive Architect/Engineer and the corresponding plans and drawings finalized;

WHEREAS, the bidding was conducted in accordance with Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act";

WHEREAS, the RBAC, in exercising its functions and in accordance with procedures pursuant to RA No. 9184 has recommended through BAC Resolution the award of contract to LGC Trucking and Construction as the winning bidder in the construction of Bislig Manpower Skills Training Center at Bislig City, Surigao Del Sur in the amount of NINE MILLION ONE HUNDRED FIFTY FIVE THOUSAND SIX HUNDRED TWENTY PESOS AND 22/100 (Php9,155,620.22);




