APPROVING THE AWARD OF CONTRACTS TO ACMI OFFICE SYSTEMS PHILS., INC. IN THE AMOUNT OF Php32,145,195.27 AND WELCOME EXPORT, INC. IN THE AMOUNT OF Php26,740,800.25 FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF VARIOUS TRAINING AND TESTING TOOLS AND EQUIPMENT

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry out domestic and foreign contracts subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, the Bids and Awards Committee (BAC) as mandated by Republic Act No. 9184 otherwise known as the "Government Procurement Reform Act" is the body tasked to post invitation to bid, conduct pre-bid conferences, determine the eligibility of prospective bidders, receive and open bids, conduct the evaluation of bids, undertake post-qualification proceedings, and recommend the award of contracts to the Head of the Procuring Entity;

WHEREAS, the Technical Education and Skills Development Authority (TESDA) intends to utilize the sum of Php59,797,000.00 being the total Approved Budget for the Contract (ABC) in the procurement of various training and testing equipment;

WHEREAS, TESDA advertised the invitation to apply for eligibility and to bid for the supply, delivery, installation, testing, training and commissioning of various tools and equipment under TESDP-GOP Fund in a newspaper of nationwide general circulation and also posted the same in the TESDA website and in the PhilGEPs continuously for fourteen (14) days;

WHEREAS, responding to the above-mentioned advertisements, four (4) prospective bidders signified their intention to submit the eligibility/pre-qualification documents;

WHEREAS, during the pre-qualification stage, three (3) of them namely: Welcome Export, Inc., ACMI Office System Phils., Inc. and State Alliance Enterprises, Inc. passed the pre-qualification; while V.G. Roxas Company, Inc., the remaining prospective bidder failed to qualify;

WHEREAS, the bid submission and opening of bids which was originally scheduled on July 24, 2009 was moved to October 27, 2009 in order to provide the qualified bidders more time to prepare their bids;

WHEREAS, during the opening of the bids, only two (2) bidders submitted their bids, to wit;

WHEREAS, a Technical Evaluation Group (TEG) was created by the Head of the Procuring Entity to assist the BAC in the evaluation of the technical specifications and assessment of bid proposals vis-à-vis agency requirements, taking into consideration the completeness of the bid in terms of specifications and prices, arithmetical corrections, current market prices, cost of all taxes and other fiscal levies and duties;

WHEREAS, the TEG has recommended the award on a per Distinct Area of Competency (DAC) basis and taking into consideration the savings incurred in the total amount of Nine Hundred Eleven Thousand Four Pesos and 48/100 only (Php911, 004.48) thus, an advantage to the Government. The BAC resolved to adopt the recommendation of the Technical Evaluation Group and to recommend to the TESDA Board to award the hereunder bidders the contracts for the deliveries of various training and testing tools and equipment as described below:






