WHEREAS, Section 8 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994," grants the Technical Education and Skills Development Authority (TESDA) Board the power to enter into, rnake, execute, perform and carry-out domestic and foreign contracts subject to existing laws, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts entered into by the TESDA;

WHEREAS, the Bids and Awards Committee (BAC), as mandated by Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, is the body tasked to post invitations to bid, to conduct pre-bid conferences, to determine the eligibility of prospective bidders, to receive and open bids, to conduct the evaluation of bids, to conduct post-qualification and to recommend award of contracts to the Head of the Procuring Entity;

WHEREAS, in view of the procurement of additional starter toolkits for the special training for employment program (STEP) for CY 2014 (Continuing Appropriation), the Director General created a Technical Working Group (TWG) that will identify the requirements for the implementation of STEP which shall necessarily include the identification of the qualifications and corresponding tools and equipment that will be covered by STEP. The TWG came out with the list of qualifications with corresponding tools and equipment in close coordination with the TESDA Regional Offices; (Annex "A" of the BAC Resolution)

WHEREAS, the Technical Education and Skills Development Authority (TESDA) intends to apply the sum of Four Million Six Hundred Twenty Seven Thousand Seven Hundred Thirty Eight Pesos and Twenty Centavos Only (Php4,627,738.20) being the total Approved Budget for the Contract (ABC) for the procurement of additional starter toolkits for the special training for employment

WHEREAS, pursuant to Section 21 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, TESDA advertised on 16 October 2015 the Invitation to Bid for the procurement of additional starter toolkits for the special training for employment program (STEP) for CY 2014 (Continuing Appropriation) in a newspaper of general circulation and posted the same in the PhilGEPS; (Annexes "E" and "F" of the BAC Resolution)

WHEREAS, responding to the abovementioned Invitation to Bid, three (3) prospective bidders signified their interest to participate in said bidding process by purchasing bidding documents, namely: 1) ACMI Office System Philippines, Incorporated, 2) JALS Trading and 3) East Pacific Industrial Trading; (Annexes "G", "H" and "I" of the BAC Resolution)

WHEREAS, the BAC in compliance also with the directive of the Director General invited several observers registered with PhilGEPS to witness the bidding activities particularly on the procurement of additional starter toolkits for the special training for employment program (STEP) for CY 2014 (Continuing Appropriation) for purposes of transparency and good governance. Pursuant to Section 13 of Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC invited

WHEREAS, accordingly, a Technical Evaluation Group (TEG) was created to conduct a bid evaluation vis-à-vis agency requirements taking into consideration the completeness of the bid in terms of technical specifications and pricing and to verify/check the performance of the bidders relative to their previous contracts with the government and private entities as provided by Section 34 of Rule X (Post-Qualification) of the Revised Implementing Rules and Regulations of Republic Act No. 9184; (Annexes "R" of the BAC Resolution)

WHEREAS, on 28 October 2015, East Pacific Industrial Trading filed its request for reconsideration requesting that the requirements under Clause 5.1 of Section III of the Bid Data Sheet as found on page 27 of the bidding documents for the procurement of additional starter toolkits for the special training for employment program (STEP) for CY 2014 (Continuing Appropriation) be changed into at least five (5) years in so far as the business existence of the bidder is concerned; (Annex "S" of the BAC Resolution)

WHEREAS, the issues and concerns of the bidders present during the prebid conference had been addressed to by the BAC through the issuance of Bid Bulletin No. 01 dated 03 November 2015 and Bulletin No. 02 dated 03 November 2015; (Annexes "T" and "U" of the BAC Resolution)

WHEREAS, East Pacific Industrial Trading was declared ineligible due to its non-compliance with the requirement that the bidder must have been in the business for five (5) years from the date of opening of bids. Hence, the BAC declared the bid of East Pacific Industrial Trading as ineligible. East Pacific Industrial Trading was given until 13 November 2015 within which to file its request for reconsideration pursuant to Section 55.1 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the BAC emphasized during the bid opening that it was East Pacific Industrial Trading which requested for the issuance of Bid Bulletin No. 02 dated 03 November 2015 changing the number of years in business existence from ten (10) years to five (5) years. As such, it is not anymore the fault of the BAC when East Pacific Industrial Trading committed an error or mistake in computing its number of years in existence in the business;

WHEREAS, only ACMI Office System Philippines, Incorporated and JALS Trading passed the eligibility requirements pursuant to Sections 23 and 25 of the Revised Implementing Rules and Regulations of Republic Act No. 9184; (Annexes "W" and "X" of the BAC Resolution)

WHEREAS, pursuant to Section 34 of Rule X (Post-Qualification) of the Revised Implementing Rules and Regulations of Republic Act No. 9184, verification and validation of the bidder's legal documentary requirements must be made. As such, the Chairperson of the TEG issued letters to Metropolitan Bank & Trust Company for the validation of the bank guarantee and Credit Line Certificate (CLC) submitted by ACMI Office System Philippines, Incorporated, BDO Unibank, Inc. for

WHEREAS, East Pacific Industrial Trading filed its request for reconsideration on 11 November 2015. Said bidder requested to be given another leeway since it admitted committing a mistake in computing the number of years of its business existence. East Pacific Industrial Trading pointed out in its letter that it is registered with the Department of Trade and Industry (DTI) on 07 December 2010 and they lacked thirty-five (35) calendar days to reach the five-year business existence; (Annex "BB" of the BAC Resolution)

WHEREAS, the BAC, in its letter dated 16 November 2015, unanimously resolved to deny the request for request for reconsideration of East Pacific Industrial Trading; (Annex "CC" of the BAC Resolution)

WHEREAS, considering the abovementioned denial of the request for reconsideration by the BAC, East Pacific Industrial Trading did not file its protest in the form of a verified position paper to the Head of the Procuring Entity (HOPE) within seven (7) calendar days from receipt of BAC's denial of the request for reconsideration as provided in Section 55.1 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, pursuant to Section 34.2 (a) of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC in its letter dated 16 November 2015 notified JALS Trading of its post-disqualification on Lot I (Service Small Engine System and Components [Leading to Motorcycle/Small Engine Servicing NC II]).
