MUNICIPALITY OF MOBO, MASBATE WITH A TOTAL AREA OF 2,000 SQUARE
METERS**

WHEREAS, Section 8 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994," grants the Technical Education and Skills Development Authority (TESDA) Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts subject to existing laws, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority;

WHEREAS, the TESDA Board during its 120th TESDA Board Meeting issued Board Resolution No. 2020-13 which grants the Director General the authority to accept and sign Deeds of Donation involving parcels of land donated by local government units and other entities on behalf of TESDA, subject to subsequent ratification of the TESDA Board;

WHEREAS, the Regional Director of TESDA-Regional Office V, Dir. Elmer K. Talavera initiated efforts to establish a Provincial Training Center in Barangay Lalaguna, Municipality of Mobo;

WHEREAS, the Municipality of Mobo owns a parcel of land located at Barangay Lalaguna, Mobo, Masbate, covered by Certificate of Title No. P-20996 and more particularly described as Lot 2777, CAD 531-D, Mobo Cadastre;

WHEREAS, as an act of liberality and generosity of the Municipality of Mobo, they agreed to donate a parcel of land covered by Certificate of Title No. P-20996 with a total area of two thousand (2,000) square meters;

WHEREAS, the Sangguniang Bayan of the Municipality of Mobo issued Resolution No. 45 series of 2020, dated 08 July 2020 entitled "*Resolution Authorizing the Municipal Mayor Honorable Raymund Osmundo N. Salvacion to Donate in Favor of Technical Education and Skills Development Authority (TESDA) Two Thousand*


