**CREATION OF THE AD HOC COMMITTEE FOR THE ENHANCEMENT OF THE
TESDA SEAL**

WHEREAS, Section 8 of Republic Act 7796, otherwise known as the "Technical Education and Skills Development Authority Act of 1994", grants the TESDA Board the power to organize and constitute various standing committees, subsidiary groups, of technical working groups for efficient integration, coordination and monitoring technical education and skills development programs at the national, regional and local levels;

WHEREAS, the TESDA seal will be officially registered to the National Historical Commission of the Philippines (NHCP) with appropriate definition of the design and symbolism in conformity with basic heraldic rules, as provided in Republic Act No. 8491 or the Flag and Heraldic Code of the Philippines;

WHEREAS, the TESDA Secretariat presented the proposed design and symbolism to the TESDA Board during the 138th TESDA Board Meeting;

WHEREAS, after a comprehensive discussion on the matter, the TESDA Board agreed to create an Ad Hoc Committee to further study and enhance the proposed TESDA design and symbolism according to the suggestions gathered during the Board Meeting for approval of the TESDA Board prior to submission to the NHCP;

WHEREAS, Board Member Randolph I. Nonato was designated as the Committee Chairperson;

NOW THEREFORE, BE IT RESOLVED, AS IT HEREBY RESOLVED, that the TESDA Board during its meeting today, 10th of May 2022 at 9:00 A.M., created the Ad Hoc Committee for the Enhancement of the TESDA Seal to be Chaired by Board Member Randolph I. Nonato, with the foregoing powers as mentioned above;
