• check and analyze nail structure and condition		
• provide protective materials for hygiene purposes		
• select and prepare appropriate sanitized tools and equipment, supplies and materials according to salon procedures

• remove nail polish completely with nail polish remover		
• remove cuticle and dry skin using appropriate tools		
• trim and file nails following customer's desired shape and style

• select and agree color of the nail polish according to customer desires or requirements		
• apply polish from the base to the edge of the nail using light sweeping stroke around the cuticle

• towel-dry and scrub hand with appropriate lotion		
• set hand PARAFFIN machine to regulate heat and achieve required melting of PARAFFIN wax (NEED TO SPECIFY THE KIND OF WAX USED AS IT WONT BE MISTAKEN AS HARD OR SOFT WAX USED FOR HAIR REMOVAL)		
• prepare and use necessary tools, supplies/materials according to OS&H requirements		
• determine and test appropriate temperature against client's respective heat tolerance		
• wrap hand with plastic gloves OR CLING PLASTIC WRAP and mittens for client requirements		
• remove PARRAFIN wax from hand according to manufacturers instructions		
• apply hand softening OR MOISTURIZING product and massages hand according to prescribed procedures		
• dispose waste products including used wax according to OS&H		
• sanitize and store tools and equipment
