RESOLUTION NO. AS-2016

RECOMMENDING THE APPROVAL OF THE AWARD OF CONTRACTS TO WELCOME EXPORT, INCORPORATED AND ACMI OFFICE SYSTEMS PHILIPPINES, INC. FOR THE PROCUREMENT OF STARTER TOOLKITS FOR THE SPECIAL TRAINING FOR EMPLOYMENT PROGRAM (STEP) FY 2016 ON A PER LOT BASIS AND DECLARING A FAILURE OF BIDDING ON LOT 39 (PERFORM HAND SPA [LEADING TO BEAUTY CARE NC II])

WHEREAS, the Bids and Awards Committee (BAC), as mandated by Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, is the body tasked to post invitations to bid, to conduct pre-bid conferences, to determine the eligibility of prospective bidders, to receive and open bids, to conduct the evaluation of bids, to conduct post-qualification and to recommend award of contracts to the Head of the Procuring Entity;

WHEREAS, in view of the procurement of starter toolkits for the Special Training for Employment Program (STEP) FY 2016, the Director General created a Technical Working Group (TWG) that will identify the requirements for the implementation of STEP which shall necessarily include the identification of the qualifications and corresponding tools and equipment that will be covered by STEP. The TWG came out with the list of qualifications with corresponding tools and equipment in close coordination with the TESDA Regional Offices. A copy of TESDA Order No. 16, Series of 2016, issued on 21 January 2016 is hereto attached as Annex "A";

WHEREAS, the Technical Education and Skills Development Authority (TESDA) intends to apply the sum of One Hundred Fifty One Million Three Hundred Sixty Five Thousand Two Hundred Eleven Pesos and Forty Four Centavos Only (Php151,365,211.44) being the total Approved Budget for the Contract (ABC) for the procurement of starter toolkits for the STEP for FY 2016. Copies of the Terms of Reference (TOR) and Obligation Request (OBR) duly approved by the Director General are hereto attached as Annexes "B" and "C", respectively;

WHEREAS, the BAC upon receipt of the TOR for the procurement of starter toolkits for the STEP FY 2016 convened on 01 February 2016 at 2:00 PM at the CSA Conference Room located at 2nd Floor of TESDA Administration Building in Taguig City to conduct a pre-procurement conference with the end-user's representative in accordance with Section 20 of the Revised Implementing Rules and Regulations of

Republic Act No. 9184. A copy of the Minutes of the Meeting is hereto attached as Annex "D";

WHEREAS, pursuant to Section 21 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, TESDA advertised on 04 February 2016 the Invitation to Bid for the procurement of starter toolkits for the STEP for FY 2016 in a newspaper of general circulation and posted the same in the PhilGEPS. Copies of which are hereto attached as Annexes "E" and "F", respectively;

WHEREAS, responding to the abovementioned Invitation to Bid, three (3) prospective bidders signified their interest to participate in said bidding process by purchasing bidding documents, namely: 1) Welcome Export, Incorporated 2) ACMI Office System Philippines, Incorporated and 3) East Pacific Industrial Trading. East Pacific Industrial Trading bought bidding documents on separate occasions. Copies of the official receipts for the purchase of bidding documents are hereto attached as Annexes "G", "H", "I", and "J", respectively;

WHEREAS, the BAC in compliance also with the directive of the Director General invited several observers registered with PhilGEPS to witness the bidding activities particularly on the procurement of starter toolkits for the STEP for FY 2016 for purposes of transparency and good governance. Pursuant to Section 13 of Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC invited several observers to attend the pre-bid conference on 15 February 2016 and the bid opening on 29 February 2016. Copies of the letters to observers are hereto attached as Annexes "K", "L", "M", "N", "O" and "P", respectively;


WHEREAS, the pre-bid conference was held on 15 February 2016 at 2:00 PM at the CSA Conference Room located at 2nd Floor of TESDA Administration Building in Taguig City. A copy of the Minutes of the Meeting is hereto attached as Annex "Q";

WHEREAS, on 19 February 2016, East Pacific Industrial Trading filed its request for reconsideration relative to the requirements prescribed in the bidding documents that the bidder must be in the business for ten (10) years. A copy of the request for reconsideration of East Pacific Industrial Trading dated 19 February 2016 is hereto attached as Annex "R";

WHEREAS, the issues and concerns of East Pacific Industrial Trading in its letter dated 19 February 2016 had been addressed to by the BAC through the issuance of Bid Bulletin No. 01 dated 19 February 2016. Copy of the bid bulletin is hereto attached as Annex "S";

WHEREAS, the bid opening was held on 29 February 2016 at 2:00 P.M. at the CSA Conference Room located at 2nd Floor of TESDA Administration Building in Taguig City. A copy of the Minutes of the Meeting is hereto attached as Annex "T";

WHEREAS, the bids of East Pacific Industrial Trading for Lots 2 (Produce Organic Vegetable [Leading to Organic Agriculture Production NC II]), 5 (Raise Swine [Leading to Animal Production NC II]), 17 (Construction Painting NC II), 18 (Install Pre-Cast Balusters and Handrail [Leading to Masonry NC II]), 20 (Masonry



NC I), 23 (Plaster Concrete/Masonry Surface [Leading to Masonry NC II]) and 24 (Tile Setting NC II) were disqualified due to the failure of East Pacific Industrial Trading to provide the procuring entity with a contract similar to the contract to be bid pursuant to Section 23.5.1.3 of the Revised Implementing Rules and Regulations of Republic Act No. 9184. As regards Lot 26 (Maintain and Repair Electronically-controlled Domestic Appliances [Leading to Consumer Electronics Servicing NC II]), East Pacific Industrial Trading failed to provide the procuring entity with a contract similar to the contract to be bid where the value is at least fifty percent (50%) of the ABC of said lot;

WHEREAS, during the bid opening, East Pacific Industrial Trading posted a Metrobank Manager's Check as bid security. However, the BAC discovered that the payee as indicated in the check was not Technical Education and Skills Development Authority but "**Technical Education and Skills Development Authority**". Said check cannot be deposited into the account of TESDA as the payee is not correctly written. The BAC unanimously declared the disqualification of East Pacific Industrial Trading because of its failure to enclose a bid security in sufficient and proper form prescribed by Section 25 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the bid offer of Welcome Export, Incorporated for Lot 27 - Maintain and Repair Cellular Phones (Leading to Consumer Electronics NC II) in the amount of Three Million Nine Hundred Thirteen Thousand Nine Hundred Six Pesos and 50/100 (Php3,913,906.50) was declared invalid. The BAC cannot determine the amount of the bid for Lot 27 of Welcome Export, Incorporated in the bidding documents. As the words shall prevail over the figures, the bid offer of Welcome Export, Incorporated was disqualified to bid for Lot 27;

WHEREAS, only ACMI Office System Philippines, Incorporated and Welcome Export, Incorporated passed the eligibility requirements pursuant to Sections 23 and 25 of the Revised Implementing Rules and Regulations of Republic Act No. 9184. East Pacific Industrial Trading was disqualified and held ineligible to bid. Copies of the Eligibility Requirements Checklist and Abstract of Bids are hereto attached as Annexes "U" and "V", respectively;

WHEREAS, since the bidding is done by lot, the BAC shall evaluate the bid offer of the participating bidder by lot;

WHEREAS, on 01 March 2016, East Pacific Industrial Trading filed its request for reconsideration relative to its failure to comply with the requirements on Bid Security and a statement of single largest completed similar contract for Lots 2, 5, 17, 18, 20, 23, 24 and 26. Copy of the request for reconsideration of East Pacific Industrial Trading dated 01 March 2016 is hereto attached as Annex "W";

WHEREAS, the BAC, in its letter dated 02 March 2016, unanimously resolved to deny the request for reconsideration of East Pacific Industrial Trading. Copy of the letter dated 02 March 2016 denying the request for reconsideration of East Pacific Industrial Trading is hereto attached as Annex "X";

WHEREAS, accordingly, a Technical Evaluation Group (TEG) was created to conduct a bid evaluation vis-à-vis agency requirements taking into consideration the completeness of the bid in terms of technical specifications and pricing and to verify/check the performance of the bidders relative to their previous contracts with the government and private entities as provided by Section 34 of Rule X (Post-Qualification) of the Revised Implementing Rules and Regulations of Republic Act No. 9184. A copy of the BAC Order No. 14, Series of 2016, issued on 01 February 2016 is hereto attached as Annex "Y";

WHEREAS, pursuant to Section 34 of Rule X (Post-Qualification) of the Revised Implementing Rules and Regulations of Republic Act No. 9184, verification and validation of the bidder's legal documentary requirements must be made. As such, the Chairperson of the TEG issued letters to Metropolitan Bank & Trust Company for the validation of the bank guarantee submitted by ACMI Office System Philippines, Incorporated and Commonwealth Insurance Company for the validation of Surety Bond submitted by Welcome Export, Incorporated and to the Accounts Receivable Monitoring Division of the Bureau Internal Revenue (BIR) for the validation of the tax clearances issued by said office to ACMI Office System Philippines, Incorporated and Welcome Export, Incorporated. Copies of the letters are hereto attached as Annexes "Z", "AA" and "BB", respectively;

WHEREAS, the abovementioned companies/offices had issued their respective confirmation letters regarding the documents submitted by ACMI Office System Philippines, Incorporated and Welcome Export, Incorporated for the procurement of starter toolkits for the STEP for FY 2016. Copies of the confirmation letters of the Metropolitan Bank & Trust Company, Commonwealth Insurance Company and Accounts Receivable Monitoring Division of the Bureau Internal Revenue (BIR) are hereto attached as Annexes "CC", "DD" and "EE", respectively;

WHEREAS, upon careful examination, validation and verification of all the technical and financial proposals submitted by ACMI Office System Philippines, Incorporated and Welcome Export, Incorporated, the TEG in its report found the bids offered by ACMI Office System Philippines, Incorporated and Welcome Export, Incorporated to be compliant with the legal, technical and financial requirements set forth by the agency pursuant to Section 34 of Rule X (Post-Qualification) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 on certain lots/qualifications. A copy of the TEG report is hereto attached as Annex "FF";

WHEREAS, according to the report of the Technical Evaluation Group (TEG), the BAC hereby resolves to adopt its findings and recommendations by way of recommending the award of the contract on a per lot basis to the bidders as follows:

WHEREAS, for Lot 27 (Maintain and Repair Cellular Phones (Leading to Consumer Electronics NC II), since Welcome Export, Incorporated was disqualified due to its invalid bid offer, ACMI Office System Philippines, Incorporated was declared to be the Single Calculated Responsive Bidder pursuant to Section 36(b) of

the Revised Implementing Rules and Regulations of Republic Act No. 9184. If after advertisement, more than one prospective bidder applies for eligibility check, but only one bidder meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements, said bidder shall be declared the Single Calculated Responsive Bidder;


WHEREAS, for Lots 2 (Produce Organic Vegetable [Leading to Organic Agriculture Production NC II]) and 34 (Perform Facial Treatment [Leading to Beauty Care NC II]), while the bid offers of Welcome Export, Incorporated are the lowest calculated bids, the Technical Evaluation Group (TEG) post-disqualified said bids for not being able to comply with the technical specifications specifically for pruning shears (Lot 2) and facial brush (Lot 34). As such, the bid offers of ACMI Office System Philippines, Incorporated were post-qualified pursuant to Section 34.5 and Section 34.6 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 which states that if the BAC determines that the bidder with the Lowest Calculated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it and notwithstanding any pending request for reconsideration thereof, the BAC shall initiate and complete the same post-qualification process on the bidder with the Second Lowest Calculated Bid. If the second bidder passes the post-qualification, and provided that the request for reconsideration of the first bidder has been denied, the second bidder shall be post-qualified as the bidder with the Lowest Calculated Responsive Bid;

WHEREAS, Welcome Export, Incorporated was notified in writing of its post-disqualification on Lot 2 (Produce Organic Vegetable [Leading to Organic Agriculture Production NC II]) and Lot 34 (Perform Facial Treatment [Leading to Beauty Care NC II]) pursuant to Section 34.5 of the Revised Implementing Rules and Regulations of Republic Act No. 9184. Copy of the Notice of Post-Disqualification is hereto attached as Annex "GG";

WHEREAS, on the basis of the TEG report, there were items offered by ACMI Office System Philippines, Incorporated and Welcome Export, Incorporated which were found to be compliant with the requirements of the agency. However, the cost of each item as offered by the bidders reached beyond fifteen percent (15%) of the agency estimate for such items while the total bid offer of such bidders per lot/qualification covering those items did not exceed the Approved Budget for the Contract (ABC) for such lot/qualification. A detailed presentation of the costing is hereto attached as Annex "HH"


