RESOLUTION NO. 23-2017

RECOMMENDING THE AWARD OF CONTRACT TO D' TRIUMPH CLEANERS AND ALLIED SERVICES, INC. FOR THE PROVISION OF JANITORIAL SERVICES REQUIREMENTS FOR TESDA CENTRAL OFFICE (JUNE 1, 2017 - DECEMBER 31, 2017) - REBIDDING

WHEREAS, the Bids and Awards Committee (BAC), as mandated by Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, is the body tasked to post invitations to bid, to conduct pre-bid conferences, to determine the eligibility of prospective bidders, to receive and open bids, to conduct the evaluation of bids, to conduct post-qualification and to recommend award of contracts to the Head of the Procuring Entity;

WHEREAS, in view of the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 – December 31, 2017) - Rebidding, the Director General created a Technical Working Group (TWG) that will assess and evaluate the janitorial requirements in the TESDA-Central Office and identify the appropriate equipment, tools and supplies intended for the use of the agency taking into consideration the technical specifications and costing. Copy of TESDA Order No. 317, Series of 2016, issued on 09 November 2016 is hereto attached as Annex "A";

WHEREAS, the BAC declared a first failure of bidding on 17 March 2017 pursuant to BAC Resolution No. 14-2017. A copy of the BAC Resolution No. 14-2017 issued on 17 March 2017 is hereto attached as Annex "B";

WHEREAS, upon review by the BAC, it was found out that there is a need to adjust the Approved Budget for the Contract (ABC). Section 35 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 authorizes the BAC to conduct a mandatory review and evaluation of the terms, conditions and specifications of the bidding documents, including its cost estimates. Based on its findings, the BAC together with the TWG saw the need to revise the terms, conditions and specifications of the bidding documents and the need to adjust the ABC pursuant to labor laws and standards. Likewise, pursuant to Government Procurement Policy Board (GPPB) Resolution No. 03-2015 entitled "Approving the Circular Clarifying the Rules on the Adjustment of the Approved Budget for the Contract", the ABC may be adjusted upwards only when there has been previous modification of the terms, conditions and specifications of the project based on Section 35 of the Revised Rules and Regulations of Republic Act No. 9184;

WHEREAS, the Technical Education and Skills Development Authority (TESDA) intends to apply the sum of Twelve Million One Hundred Seventy-Six Thousand Six Hundred Eighty-One Pesos and 902/1000 (Php12,176,681.902) for the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 - December 31, 2017) - Rebidding. A copy of the Terms of Reference (TOR) and Obligation Request and Status (ORS) are hereto attached as Annexes "C" and "D", respectively;

WHEREAS, the BAC upon receipt of the TOR for the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 - December 31, 2017) - Rebidding convened on 24 March 2017 at 2:30 p.m. at the CSA Conference Room located at the 2nd Floor, TESDA Administration Building in Taguig City to conduct a pre-procurement conference with the end-user's representative in accordance with Section 20 of the Revised Implementing Rules and Regulations of Republic Act No. 9184. A copy of the Minutes of the Meeting is hereto attached as Annex "E";

WHEREAS, pursuant to Section 21 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, TESDA advertised the Invitation to Bid for the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 - December 31, 2017) - Rebidding in two (2) newspapers of general circulation and posted the same in the PhilGEPS on 01 April 2017. Copies of which are hereto attached as Annexes "F", "G" and "H", respectively;




WHEREAS, responding to the abovementioned Invitation to Bid, three (3) prospective bidders signified their interest to participate in said bidding process by purchasing bidding documents namely 1) D' Triumph Cleaners and Allied Services, Inc., 2) Philcare Manpower Services and 3) Superclean Services Corporation. Copies of the official receipt for the purchase of bidding documents are hereto attached as Annexes "I", "J" and "K", respectively;

WHEREAS, the BAC in compliance also with the directive of the Director General invited several observers registered with PhilGEPS to witness the bidding activities particularly on the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 - December 31, 2017) - Rebidding for purposes of transparency and good governance. Pursuant to Section 13 of Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC invited several observers to attend the pre-bid conference on 10 April 2017 and the bid opening on 24 April 2017. Copies of the letters to observers are hereto attached as Annexes "L", "M", "N", "O", "P" and "Q", respectively;

WHEREAS, the pre-bid conference was held on 10 April 2017 at 2:08 p.m. at the CSA Conference Room located at the 2nd Floor, TESDA Administration Building in Taguig City. A copy of the Minutes of the Meeting is hereto attached as Annex "R";

WHEREAS, the bid opening was held on 24 April 2017 at 2:12 p.m. at the CSA Conference Room located at the 2nd Floor, TESDA Administration Building in Taguig City. A copy of the Minutes of the Meeting is hereto attached as Annex "S";

WHEREAS, D' Triumph Cleaners and Allied Services, Inc., Superclean Services Corporation and Philcare Manpower Services passed the eligibility requirements pursuant to Sections 23 and 25 of the Revised Implementing Rules and Regulations of Republic Act No. 9184. A copy of the Eligibility Requirements Checklist and Abstract of Bids are hereto attached as Annexes "T" and "U", respectively;



WHEREAS, accordingly, a Technical Evaluation Group (TEG) was created to conduct bid evaluation vis-à-vis agency requirements taking into consideration the completeness of the bid in terms of technical specifications and pricing and to verify/check the performance of the bidders relative to their previous contracts with the government and private entities as provided by Section 34 of Republic Act No. 9184. A copy of the BAC Order No. 03, Series of 2017, issued on 24 April 2017 is hereto attached as Annex "V";



WHEREAS, pursuant to Section 34 of Rule X (Post-Qualification) of the Revised Implementing Rules and Regulations of Republic Act No. 9184, verification and validation of the bidder's legal documentary requirements must be made. As such, the Chairperson of the TEG issued a letter to the Accounts Receivable Monitoring Division of the Bureau Internal Revenue (BIR) for the validation of the tax clearance issued by said office to Philcare Manpower Services being the Lowest Calculated Bidder with a bid offer of Ten Million Six Hundred Forty-Nine Thousand Seven Hundred Nineteen Pesos and 99/100 (Php10,649,719.99). A copy of the letter to the BIR is hereto attached as Annex "W";

WHEREAS, the abovementioned office had issued confirmation letter regarding the documents submitted by Philcare Manpower Services for the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 - December 31, 2017) - Rebidding. A copy of the confirmation letter of the Accounts Receivable Monitoring Division of the BIR is hereto attached as Annex "X";

WHEREAS, pursuant to Section 25.2.a (viii) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 which requires prospective bidders or its duly authorized representatives to submit a sworn statement in the form prescribed by the GPPB that it complies with existing labor laws and standards, compliance by the bidders with the foregoing shall be supported with the clearances or certifications from the Department of Labor and Employment (DOLE), National Labor Relations Commission (NLRC), Social Security System (SSS), Philippine Health Insurance Corporation (PhilHealth) and Pag-IBIG Fund. Clearances must be issued at least within three (3) months from the date of bid opening. This is pursuant to GPPB Resolution No. 01-2008 issued on 07 March 2008 giving the procuring entity the discretion whether to require the clearances from the bidders;

WHEREAS, Philcare Manpower Services submitted during the bid opening a certification from the Department of Labor and Employment (DOLE) certifying that it has no pending case before said office in compliance with the eligibility requirements prescribed under Clause 5.1.4 of Section III (Bid Data Sheet) of page 39 of the bidding documents. The certificate of registration of the bidder per DOLE Department Order No. 18-A will expire on 29 April 2017. Copy of the foregoing certificate is hereto attached as Annex "Y";

WHEREAS, Philcare Manpower Services submitted a certification from National Labor Relations Commission (NLRC) certifying that it has no pending case before said office. Copy of the certificate issued by NLRC is hereto attached as Annex "Z";



WHEREAS, Philcare Manpower Services submitted a certification from Social Security System (SSS) certifying that Philcare Manpower Services has remitted the contributions of its employees from July 2008 up to March 2017 to SSS and that it has no pending case before said office. Copy of the clearance issued by SSS is hereto attached as Annex "AA";

WHEREAS, Philcare Manpower Services submitted a certification from Philippine Health Insurance Corporation (PhilHealth) that it has remitted premium contributions of its employees from January 2016 up to December 2016. Copy of the certificate issued by PhilHealth is hereto attached as Annex "BB";

WHEREAS, Philcare Manpower Services submitted certification from Pag-IBIG Fund that it has remitted premium contributions of its employees from May 1984 up to December 2016. Copy of the certificate issued by Pag-IBIG Fund is hereto attached as Annex "CC";

WHEREAS, the Chairperson of the TEG issued letters to the Department of Labor and Employment (DOLE), National Labor Relations Commission (NLRC), Social Security System (SSS), Philippine Health Insurance Corporation (PhilHealth) and Pag-IBIG Fund for the validation of the documents issued by said offices to Philcare Manpower Services. Copies of the documents are hereto attached as Annexes "DD", "EE", "FF", "GG" and "HH", respectively;

WHEREAS, the abovementioned government agencies had issued their respective confirmation regarding the clearances/certifications submitted by Philcare Manpower Services for the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 - December 31, 2017) - Rebidding. Copies of the confirmation of the Department of Labor and Employment (DOLE), National Labor Relations Commission (NLRC), Social Security System (SSS), Philippine Health Insurance Corporation (PhilHealth) and Pag-IBIG Fund are hereto attached as Annexes "II", "JJ", "KK", "LL" and "MM", respectively;

WHEREAS, the TEG in its report found the bid offered by Philcare Manpower Services to be not compliant with the requirements set forth by the agency pursuant to Section 34 of Rule X (Post-Qualification) of the Revised Implementing Rules and Regulations of Republic Act No. 9184. A copy of the TEG report is hereto attached as Annex "NN";

WHEREAS, Philcare Manpower Services was post-disqualified due to its failure to comply with the requirements of TESDA specifically on the computation of what is due to every janitor. The TEG verified with DOLE the computation of the minimum wage and other monetary benefits that should be accorded to every janitor;

WHEREAS, the BAC found out through the certification of the DOLE that Philcare Manpower Services applied for the renewal of its certificate of registration before said office on 26 April 2017 considering that it expired on 29 April 2017. After the expiration of the certificate of registration of the bidder on 29 April 2017, the application for renewal of the certificate of registration of the bidder is pending for approval by the DOLE. A copy of the certification of the DOLE dated 09 May 2017 is hereto attached as Annex "OO";

WHEREAS, the BAC unanimously post-disqualified the bid of Philcare Manpower Services pursuant to Section 34 of the Revised Implementing Rules and Regulations of the Republic Act No. 9184 through an issuance of BAC Resolution No. 18-2017. A copy of BAC Resolution No. 18-2017 issued on 10 May 2017 is hereto attached as Annex "PP";

WHEREAS, Philcare Manpower Services received the BAC Resolution No. 18-2017 stating that the bid of said bidder was post-disqualified due to non-compliance with the requirements of TESDA specifically on the computation of what is due to every janitor and expiration of its certificate of registration. The bidder had been given three (3) calendar days from 12 May 2017 or until 15 May 2017 within which to file its request for reconsideration pursuant to Section 55.1 of Rule XVII (Protest Mechanism) of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, Philcare Manpower Services filed its request for reconsideration on 15 May 2017. In its request for reconsideration, the bidder contested that they have committed an arithmetical error which can be cured by submitting a corrected computation of their bid offer pursuant to Section 32.2.1.b of the Revised Implementing Rules and Regulations of Republic Act No. 9184. Likewise, the issue on the non-submission of the latest DOLE certificate of registration is of no moment because they had submitted a valid DOLE certificate of registration during the bid opening. A copy of its request for reconsideration is hereto attached as Annex "QQ";

WHEREAS, the BAC denied the request for reconsideration of Philcare Manpower Services through the issuance of BAC Resolution No. 20-2017 issued on 15 May 2017. The BAC argued that the contention that Philcare Manpower Services has already a pending application for renewal of its certificate of registration in compliance with DOLE Department Order No. 174, Series of 2017, is of no moment. It is necessary to emphasize that a "pending application" for renewal of certificate or registration cannot be categorically equated to an "approved" application for renewal of certificate of registration. The fact that the same application for renewal is pending before DOLE simply means that the same is still subject to evaluation of DOLE especially now that it has set forth higher and stricter requirements for renewal of the certificate of registration of a labor contractor under Department Order No. 174-17, Series of 2017. Likewise, the BAC already amply discussed in its assailed BAC Resolution No. 18-2017 the failure of Philcare Manpower Services to comply with the requirements of the labor law on the computation of what is due to every janitor which cannot be set aside being not a mere mathematical error. The computation of what is due to every janitor made by Philcare Manpower Services forms part of its bid offer and the same cannot be considered as mere computational errors that will be resolved simply by arithmetical corrections. To do so will totally modify the bid offer of Philcare Manpower Services which the BAC cannot allow. Philcare Manpower Services could not fault the BAC for its failure to comply with requirements of TESDA considering that such requirements were clearly prescribed in the bidding documents and clarified during the pre-bid conference and bid opening on 10 April 2017 and 24 April 2017, respectively. Said requirements being pointed out here is the compliance by the bidder with labor laws and standards among others. A copy of BAC Resolution No. 20-2017 issued on 15 May 2017 is hereto attached as Annex "RR";

WHEREAS, Superclean Services Corporation had been declared as the next Lowest Calculated Bidder since its bid offer amounting to Ten Million Eight Hundred Eighty-Four Thousand Seven Hundred Seventy-Two Pesos and 36/100 (Php10,884,772.36) is the next lowest bid offer among the three (3) bidders after Philcare Manpower Services had been post-disqualified through the issuance of BAC Resolution No. 18-2017;

WHEREAS, pursuant to Section 34.6 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, immediately after the BAC has notified the first bidder of its post-disqualification, and notwithstanding any pending request for reconsideration thereof, the BAC shall initiate and complete the same post-qualification process on the bidder with the second Lowest Calculated Bid/Highest Rated Bid;

WHEREAS, Superclean Services Corporation submitted during the bid opening a certification from the DOLE certifying that it has no pending case before said office in compliance with the eligibility requirements prescribed under Clause 5.1.4 of Section III (Bid Data Sheet) of page 39 of the bidding documents. The certificate of registration of the bidder per DOLE Department Order No. 18-A had expired on 05 September 2016. Copy of the foregoing certificate is hereto attached as Annex "SS";

WHEREAS, Superclean Services Corporation submitted a certification from NLRC certifying that it has no pending case before said office. Copy of the certificate issued by NLRC is hereto attached as Annex "TT";

WHEREAS, Superclean Services Corporation submitted a certification from SSS certifying that Superclean Services Corporation has remitted the contributions of its employees from January 1981 up to January 2017 to SSS. However, they cannot issue the necessary clearance because Superclean Services Corporation is delinquent in the remittance of salary loan amortization in the total amount of Nine Hundred Fifteen Thousand One Hundred Fifty-Three Pesos and 81/100 (Php915,153.81). Copy of the clearance issued by SSS is hereto attached as Annex "UU";

WHEREAS, Superclean Services Corporation submitted a certification from PhilHealth that it has remitted premium contributions of its employees from August 2016 up to November 2016. Copy of the certificate issued by PhilHealth is hereto attached as Annex "VV";

WHEREAS, Superclean Services Corporation submitted certification from Pag-IBIG Fund that it has remitted premium contributions of its employees from July 1981 up to December 2016. Copy of the certificate issued by Pag-IBIG Fund is hereto attached as Annex "WW";

WHEREAS, Superclean Services Corporation had already submitted the certifications issued by the NLRC, SSS, PhilHealth and Pag-IBIG Fund in the previous procurement of janitorial services on 09 March 2017 which had already been verified by the BAC;

WHEREAS, the Chairperson of the TEG issued a letter to the DOLE for the validation of the document issued by said office to Superclean Services Corporation. Likewise, the status of the application for renewal of the certificate of registration of said bidder in compliance with DOLE Department Order No. 18-A was verified in writing. A copy of the letter to DOLE is hereto attached as Annex "XX";

WHEREAS, the DOLE had issued its confirmation regarding the certification submitted by Superclean Services Corporation for the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 - December 31, 2017) - Rebidding. It is stated in the said letter that the bidder is a registered contractor under Department Order No. 174-17, Series of 2017, with registration number of NCR-PFO-90090-0509-17-01-N which is valid until 08 May 2019. Copies of the certifications of the DOLE are hereto attached as Annexes "YY" and "ZZ";

WHEREAS, the TEG in its report found the bid offered by Superclean Services Corporation to be not compliant with the financial requirements set forth by the agency pursuant to Section 34 of Rule X (Post-Qualification) of the Revised Implementing Rules and Regulations of Republic Act No. 9184. A copy of the TEG report is hereto attached as Annex "AAA";

WHEREAS, Superclean Services Corporation was post-disqualified due to its failure to comply with the requirements of the labor law on the computation of what is due to every janitor;

WHEREAS, the BAC unanimously post-disqualified the bid of Superclean Services Corporation pursuant to Section 34 of the Revised Implementing Rules and Regulations of the Republic Act No. 9184 through an issuance of BAC Resolution No. 19-2017. A copy of BAC Resolution No. 19-2017 dated 15 May 2017 is hereto attached as Annex "BBB";

WHEREAS, Superclean Services Corporation received the BAC Resolution No. 19-2017 stating that the bid of said bidder was post-disqualified due to non-compliance with the requirements of TESDA specifically on the computation of what is due to every janitor. The bidder had been given three (3) calendar days from 15 May 2017 or until 18 May 2017 within which to file its request for reconsideration pursuant to Section 55.1 of Rule XVII (Protest Mechanism) of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, Superclean Services Corporation filed its request for reconsideration on 17 May 2017. In its request for reconsideration, the bidder contested that they have followed followed the formula suggested by DOLE for the computation of the Estimated Equivalent Monthly Rate (EEMR) of the Daily-Paid Employees. However, they admitted that they have not included the Cost of Living Allowance (COLA) amounting to Ten Pesos (Php10.00) in the computation of the one (1) day holiday pay in the computation of its bid offer. A copy of its request for reconsideration is hereto attached as Annex "CCC";

WHEREAS, the BAC had already amply discussed in its assailed BAC Resolution No. 19-2017 the failure of Superclean Services Corporation to comply with the requirements of the labor law on the computation of what is due to every janitor which cannot be set aside being not a mere mathematical error or simply an omission. The computation of what is due to every janitor made by Superclean Services Corporation forms part of its bid offer and the same cannot be considered as mere computational errors that will be resolved simply by including the COLA amounting to Ten Pesos (Php10.00) in the computation of the one (1) day holiday pay. To do so will totally modify the bid offer of Superclean Services Corporation which the BAC cannot allow. Superclean Services Corporation could not fault the BAC for its failure to comply with requirements of TESDA considering that such requirements were clearly prescribed in the bidding documents and clarified during the pre-bid conference and bid opening on 10 April 2017 and 24 April 2017, respectively. Said requirements being pointed out here is the compliance by the bidder with labor laws and standards among others. A copy of BAC Resolution No. 21-2017 issued on 10 May 2017 is hereto attached as Annex "DDD";

WHEREAS, since Philcare Manpower Services and Superclean Services Corporation were already post-disqualified, the TEG would post-qualify D' Triumph Cleaners and Allied Services, Inc.;

WHEREAS, pursuant to Section 34 of Rule X (Post-Qualification) of the Revised Implementing Rules and Regulations of Republic Act No. 9184, verification and validation of the bidder's legal documentary requirements must be made. As such, the Chairperson of the TEG issued a letter to the Accounts Receivable Monitoring Division of the BIR for the validation of the tax clearance issued by said office to D' Triumph Cleaners and Allied Services, Inc. A copy of the letter to the BIR is hereto attached as Annex "EEE";

WHEREAS, the abovementioned office had issued confirmation letter regarding the documents submitted by D' Triumph Cleaners and Allied Services, Inc. for the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 - December 31, 2017) - Rebidding. A copy of the confirmation letter of the Accounts Receivable Monitoring Division of the BIR is hereto attached as Annex "FFF";

WHEREAS, D' Triumph Cleaners and Allied Services, Inc. submitted during the bid opening a certification from the DOLE certifying that it has no pending case before said office in compliance with the eligibility requirements prescribed under Clause 5.1.4 of Section III (Bid Data Sheet) of page 39 of the bidding documents. Copy of the foregoing certificate is hereto attached as Annex "GGG";

WHEREAS, D' Triumph Cleaners and Allied Services, Inc. submitted a certification from NLRC certifying that it has no pending case before said office. Copy of the certificate issued by NLRC is hereto attached as Annex "HHH";

WHEREAS, D' Triumph Cleaners and Allied Services, Inc. submitted a certification from SSS certifying that D' Triumph Cleaners and Allied Services, Inc. has remitted the contributions of its employees from October 2003 up to January 2017 to SSS and that it has no pending case before said office. Copy of the clearance issued by SSS is hereto attached as Annex "III";

WHEREAS, D' Triumph Cleaners and Allied Services, Inc. submitted a certification from PhilHealth that it has remitted premium contributions of its employees from January 2016 up to December 2016. Copy of the certificate issued by PhilHealth is hereto attached as Annex "JJJ";

WHEREAS, D' Triumph Cleaners and Allied Services, Inc. submitted certification from Pag-IBIG Fund that it has remitted premium contributions of its employees from October 2003 up to February 2017. Copy of the certificate issued by Pag-IBIG Fund is hereto attached as Annex "KKK";

WHEREAS, the Chairperson of the TEG issued letters to the DOLE, NLRC, SSS, PhilHealth and Pag-IBIG Fund and for the validation of the documents issued by said offices to D' Triumph Cleaners and Allied Services, Inc. Copies of the documents are hereto attached as Annexes "LLL", "MMM", "NNN", "OOO" and "PPP", respectively;

WHEREAS, the abovementioned government agencies had issued their respective confirmation regarding the clearances/certifications submitted by D' Triumph Cleaners and Allied Services, Inc. for the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 - December 31, 2017) - Rebidding. Copies of the confirmation of the DOLE, NLRC, SSS, PhilHealth and Pag-IBIG Fund are hereto attached as Annexes "QQQ", "RRR", "SSS", "TTT" and "UUU", respectively;


WHEREAS, the TEG in its report found the bid offered by D' Triumph Cleaners and Allied Services, Inc. to be compliant with the legal, technical and financial requirements set forth by the agency pursuant to Section 34 of Rule X (Post-Qualification) of the Revised Implementing Rules and Regulations of Republic Act No. 9184. A copy of the TEG report is hereto attached as Annex "VVV";

WHEREAS, pursuant to Section 34.7 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, if the second bidder failed the post-qualification, the procedure for post-qualification shall be repeated for the bidder with the next Lowest Calculated Bid, and so on until the Lowest Calculated Responsive Bid is determined for award;


WHEREAS, D' Triumph Cleaners and Allied Services, Inc. met all the eligibility requirements prescribed by the agency and its bid had been found to be responsive to the bidding requirements. Hence, the BAC finds the bid of D' Triumph Cleaners and Allied Services, Inc. to be the Lowest Calculated Responsive Bid pursuant to Section 34.7 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to recommend the award of the contract to D' Triumph Cleaners and Allied Services, Inc. as the bidder with a Lowest Calculated Responsive Bid for the Provision of Janitorial Services Requirements for TESDA Central Office (June 1, 2017 - December 31, 2017) - Rebidding in the total amount of Twelve Million One Hundred Seventy-Six Thousand Five Hundred Pesos (Php12,176,500.00) subject to government accounting and auditing rules and regulations.


