DECLARING A FAILURE OF BIDDING FOR LOTS 1, 2, 3, AND 5 UNDER THE PROCUREMENT OF STARTER TOOLKITS FOR THE IMPLEMENTATION OF FY 2020 UNIVERSAL ACCESS TO QUALITY TERTIARY EDUCATION ACT (UAQTEA) - SINGLE/BUNDLED PROGRAMS - HEALTH, SOCIAL AND OTHER COMMUNITY DEVELOPMENT SERVICES SECTOR

WHEREAS, the Bids and Awards Committee (BAC), as mandated by Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, is the body tasked to post invitations to bid, to conduct pre-bid conferences, to determine the eligibility of prospective bidders, to receive and open bids, to conduct the evaluation of bids, to conduct post-qualification and to recommend award of contracts to the Head of the Procuring Entity;

WHEREAS, the bid opening for the Procurement of Starter Toolkits for the Implementation of FY 2020 Universal Access to Quality Tertiary Education Act (UAQTEA) Single/Bundled Programs - Health, Social and Other Community Development Services Sector was held on 16 November 2020. Likewise, ACMI Office Systems Philippines Inc., Dominion Intertrade Corporation, and Welcome Export Inc. submitted their respective bidding documents for the said project;

WHEREAS, ACMI Office Systems Philippines Inc., Dominion Intertrade Corporation, and Welcome Export Inc. passed the eligibility requirements pursuant to Sections 23 and 25 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184;

WHEREAS, Dominion Intertrade Corporation had been declared as the Lowest Calculated Bidder for the following lots under the Procurement of Starter Toolkits for the Implementation of FY 2020 UAQTEA - Singled/Bundled Programs - Health, Social and Other Community Development Services Sector:

WHEREAS, Welcome Export Inc. had been declared as the Lowest Calculated Bidder for Lot 5-Hair Dressing NC II under the Procurement of Starter Toolkits for the Implementation of FY 2020 UAQTEA - Singled/Bundled Programs - Health, Social and Other Community Development Services Sector;

WHEREAS, Welcome Export Inc. was post-disqualified for Lot 5-Hair Dressing NC II under the Procurement of Starter Toolkits for the Implementation of FY 2020 UAQTEA - Singled/Bundled Programs - Health, Social and Other Community Development Services Sector pursuant to BAC Resolution No. 22-2021 dated 3 February 2021;

WHEREAS, if all bids failed to comply with all the bid requirements or fail the post-qualification, the BAC shall declare a failure of bidding pursuant to Section 35.1 (c) of the 2016 RIRR of RA 9184. As such, the BAC declared a failure of bidding for the following lots under the Procurement of Starter Toolkits for the Implementation of FY 2020 UAQTEA - Singled/Bundled Programs - Health, Social and Other Community Development Services Sector;

Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a rebidding with re-advertisement and/or posting, as provided for in Section 21.2 of 2016 RIRR of Republic Act No. 9184;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to declare a failure of bidding for lots 1, 2, 3, and 5 under the Procurement of Starter Toolkits for the Implementation of FY 2020 UAQTEA - Singled/Bundled Programs -Health, Social and Other Community Development Services Sector pursuant to Section 35.1 (c) of the 2016 RIRR of RA 9184 and to conduct a rebidding subject to the instruction of the approving authority and provisions of Republic Act No. 9184 and its RIRR.
