

Name of Project: **Supply, Delivery, Testing, Implementation and Deployment of, and Training on Next Generation Firewall with Logging and Reporting Appliance**

Pursuant to Section 22.5 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, this Bid Bulletin No. 2 is being issued to further clarify the provisions in the Bidding Documents with reference to the queries/concerns raised by Infobahn Communications, Inc.

On the query of Infobahn Communications, Inc. relative to the requirement of certification from the manufacturer of the equipment that the bidder is a certified partner of the product being offered, TESDA shall require such certification in order to ensure that the bidder is authorized and certified to bid and is capable of providing support to TESDA.

In regard to the forms for the Omnibus Sworn Statement and Bid Form, kindly disregard the ones attached in the Bidding Documents, and use the revised forms provided in the Government Procurement Policy Board (GPPB) Resolution No. 16-2020 dated 16 September 2020 as hereto attached as Annexes **A** and **B** of this Bid Bulletin for your perusal.
