

**CONTRACT FOR THE PROCUREMENT OF STARTER TOOLKITS FOR THE  
IMPLEMENTATION OF FY 2020 SPECIAL TRAINING FOR EMPLOYMENT  
PROGRAM (STEP) - AGRICULTURE, FORESTRY, AND FISHERY SECTOR  
Lot 16 - Support Nursery Work (Leading to Agricultural Crop Production NC I)**

THIS CONTRACT made this 15 day of MAR 2021 by and between **TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA)** with principal address at TESDA Complex, East Service Road, South Luzon Expressway, Fort Bonifacio, Taguig City, Metro Manila, Philippines (hereinafter called the "**Procuring Entity**") of the one part and **TECHGURU INCORPORATED** with business address at Room 525, 5<sup>th</sup> Floor, Downtown Center Building, 516 Quintin Paredes Street, Binondo, Manila (hereinafter called the "**Supplier**") of the other part;

**WHEREAS**, the Procuring Entity invited Bids for certain goods and ancillary services, particularly for **Lot 16 - Support Nursery Work (Leading to Agricultural Crop Production NC I)** under the Procurement of Starter Toolkits for the Implementation of FY 2020 STEP - Agriculture, Forestry, and Fishery Sector and has accepted a Bid from the supplier in the sum of **One Million Fifty-Four Thousand Three Hundred Seven Pesos and 97/100 (P1,054,307.97)** (hereinafter called "**the Contract Price**").

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

3. Delivery Period and Delivery Place:

**Delivery Period:** Within **ninety (90) calendar days** upon receipt of Notice to Proceed (NTP)

**Delivery Place:** Various TESDA Regional Offices per Annex A of the TESDA Bidding Documents

4. In consideration of the payments to be made by the **PROCURING ENTITY** to the **SUPPLIER** as hereinafter mentioned, the **SUPPLIER** hereby covenants with the **PROCURING ENTITY** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
5. Payment in favor of the **SUPPLIER** shall only be made upon full delivery and final acceptance of the toolkits.
6. The **PROCURING ENTITY** hereby covenants to pay the **SUPPLIER** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable subject to applicable withholding tax under the provisions of this Contract at the time and in the manner prescribed by the Contract.

**IN WITNESS WHEREOF**, the parties hereto have caused this Contract to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




