

**CONTRACT FOR THE PROCUREMENT OF STARTER TOOLKITS FOR THE

THIS CONTRACT made this \_\_\_\_\_ day of MAR 15 2021 2021 by and between **TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA)** with principal address at TESDA Complex, East Service Road, South Luzon Expressway, Fort Bonifacio, Taguig City, Metro Manila, Philippines (hereinafter called the "**Procuring Entity**") of the one part and **TECHGURU INCORPORATED** with business address at Room 525, 5<sup>th</sup> Floor, Downtown Center Building, 516 Quintin Paredes Street, Binondo, Manila (hereinafter called the "**Supplier**") of the other part;

**WHEREAS**, the Procuring Entity invited Bids for certain goods and ancillary services, particularly for **Lot 8 - Perform Multiple Plumbing Installation and Repair Maintenance Works (Leading to Plumbing NC II)** under the Procurement of Starter Toolkits for the Implementation of FY 2020 STEP - General Infrastructure Sector and has accepted a Bid from the supplier in the sum of **Six Hundred Twenty-Five Thousand Three Hundred Eighty-Two Pesos and 40/100 (P625,382.40)** (hereinafter called "**the Contract Price**").

**Delivery Place:** Various TESDA Regional Offices per Annex A of the TESDA Bidding Documents





5. Payment in favor of the **SUPPLIER** shall only be made upon full delivery and final acceptance of the toolkits.
6. The **PROCURING ENTITY** hereby covenants to pay the **SUPPLIER** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable subject to applicable withholding tax under the provisions of this Contract at the time and in the manner prescribed by the Contract.


