**WHEREAS**, the Procuring Entity invited Bids for certain goods and ancillary services, particularly for **Lot 3 - Animal Production (Ruminants) NC II** under the Procurement of Starter Toolkits for the Implementation of FY 2020 STEP - Agriculture, Forestry, and Fishery Sector and has accepted a Bid from the supplier in the sum of **Four Million Four Hundred Fifty Thousand Three Hundred Eighteen Pesos and 64/100 (P4,450,318.64)** (hereinafter called "**the Contract Price**").

**Delivery Period:** Within **ninety (90) calendar days** upon receipt of Notice to Proceed (NTP)


**Delivery Place:** Various TESDA Regional Offices per Annex A of the TESDA Bidding Documents



5. Payment in favor of the **SUPPLIER** shall only be made upon full delivery and final acceptance of the toolkits.
6. The **PROCURING ENTITY** hereby covenants to pay the **SUPPLIER** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable subject to applicable withholding tax under the provisions of this Contract at the time and in the manner prescribed by the Contract.


