Name of Project: Supply and Delivery of One (1) Unit Passenger Van and Sixteen (16) Units Pickup Trucks for the Technical Education and Skills Development Authority (TESDA)

Pursuant to Section 22.5 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, this Bid Bulletin No. 1 is being issued to further clarify the provisions in the Bidding Documents with reference to the queries/concerns raised by the bidders.

- 1. On the query on the participation on only one (1) lot
 - The prospective bidder may opt to bid on either of the two (2) lots or on both lots since the bidding for this procurement project is on a per lot basis.
- On the number of copy/set to be submitted by the prospective bidder (Section III of the Bidding Documents)
 - As stated in Instruction to Bidders (ITB) Clause No. 15 under Section III (Bid Data Sheet) of the Bidding Documents, each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity requests two (2) additional hard copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

- On the submission of a Certification from the Manufacturer that the Brand of the motor vehicle being offered has been in the Philippine Market for the last twenty (20) years as one of the documentary requirements for post-qualification (Section III of the Bidding Documents)
 - It must be stressed that only the manufacturer of the brand can fully attest that the motor vehicle being offered by the bidder has been in the Philippine Market for the last twenty (20) years.
- 4. On the payment terms (Section IV of the Bidding Documents)
 - Payment shall be made within thirty (30) working days provided that the delivery of the motor vehicles and the inspection of the goods are completed.

Each unit shall include Brochures which include but not limited to Manual, Warranty Booklet, Operations Manual for Accessories, Warranty Booklet for Air-conditioning Unit and operations and maintenance manuals in English.

- · Each vehicle must have 10 liters of fuel in the tank upon delivery
- Registration and Insurance
 - Free LTO Registration for three (3) years.
 - Free one (1) year Comprehensive Insurance with Acts of God and TPL.

· Each vehicle must be registered under Government Plate Registration

* Bidders must state here either "Comply" or "Not Comply" against each of the individual parameters of each Specification stating the corresponding performance parameter of the equipment offered. Statements of "Comply" or "Not Comply" must be supported by evidence in a Bidders Bid and cross-referenced to that evidence. Evidence shall be in the form of manufacturer's un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data etc., as appropriate. A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection. A statement either in the Bidder's statement of compliance or the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the applicable laws and issuances.
